City Council Minutes January 7, 2025

Orangeburg City Council held its regularly scheduled meeting on Tuesday January 7, 2025, at 6:00 pm in Council Chambers, 933 Middleton Street with Mayor Michael C. Butler presiding.

A motion was made by Councilmember Stroman, seconded by Councilmember Knotts to approve December 17, 2024, minutes. The motion was unanimously approved.

Mayor Butler recognized Patience as the January Orangeburg County Community of Character Trait.

Dr. Fabien McGill addressed Council concerning the Willie Jeffries School of Excellence. He stated, "We are located on Five Chop Road and are currently in our first phase of building. We will start the second phase soon and we plan to be in our building by the end of 2025. I think what makes us different is our culture and climate. When you walk through our hallways, you hear laughter, learning and joy. I want to encourage you to visit, and I welcome feedback as there are always areas of improvement. I think we have the best staff in the state, and we are building our students for success in the future. We make sure we hire teachers that love children. We have personalized learning plans which means we will focus on every individual student to make sure that we identify what each student needs to succeed. Then we can find their loves and passions to succeed in their goals. We focus on student engagement and are currently creating clubs, activities, and sports. We have pledge cards here tonight as funding is required to accomplish our goals."

City Administrator Evering addressed Council concerning third reading of an ordinance authorizing the transfer of approximately 0.03 acres of real property with improvements, if any, located at the corner of Russell Street and Middleton Street (1192 Middleton Street, formerly known as 1198 Russell Street), with County TMS #0173-13-35-002.000. He stated, "This is the green building on the corner of Russell and Middleton Streets. There is a local buyer and investor that would like to purchase the building for \$75,000 to put condominiums and retail space in the building. This ordinance would authorize the sale of that property for those purposes."

A motion was made by Mayor Pro Tem Keitt, seconded by Councilmember Stroman to approve third reading of an ordinance authorizing the transfer of approximately 0.03 acres of real property with improvements, if any, located at the corner of Russell Street and Middleton Street (1192 Middleton Street, formerly known as 1198 Russell Street), with County TMS #0173-13-35-002.000. The motion was unanimously approved.

I would like to highlight a few of the legislative advocacy initiatives to include protecting the authority of cities and towns to regulate short-term rentals within municipal boundaries, allow cities and towns with no property tax millage to impose a millage within certain limitations, allow cities to place a Municipal Project Sales Tax penny on a referendum for city residents to vote on additional revenue for capital projects in their city,

support funding for police equipment and infrastructure and support legislature that allows retirees to return to work with no earning cap placed on their retirement benefits.".

A motion was made by Councilmember Grevious, seconded by Councilmember Knotts to approve the resolution to support the Municipal Association of South Carolina (MASC) 2025-2026 Legislative Advocacy Initiatives. The motion was unanimously approved.

A motion was made by Councilmember Stroman, seconded by Mayor Pro Tem Keitt to go into Executive Session concerning discussion of negotiations incident to proposed contractual arrangements and/or the receipt of legal advice S.C. Code Sec. 30-4-70(a)(2) a) Vape Ordinance, b) Hillcrest Lease Agreement, and discussion of employment, compensation, promotion, demotion, discipline, or release of an employee – Personnel Matter SC Code Sec. 30-4-70(a)(1). The motion was unanimously approved.

Council did not return from Executive Session. There being no further business, the meeting was adjourned.
